#### • Do's √

- Rosslare Europort will operate under pre-boarding notification rules within the ROI Customs roll-on/roll-off service. A pre-boarding notification reference number or (PBN) will be issued by ROI Customs and will be required at check-in for all imports into ROI and all exports out of ROI.
- You must have a valid shipping booking reference number to enter the port.
- Prior to check in please ensure that Export and Import Customs
   Declarations have been lodged with the relevant customs authorities
   including all safety and security declarations, for both accompanied and
   unaccompanied shipments. This can be done directly or through a customs
   agent.
- Prior to arrival in Rosslare Europort, go to <a href="www.revenue.ie/roro">www.revenue.ie/roro</a> enter your pre-boarding notification (PBN) ID and wait for the message "Good to proceed to check-in" Leaving Ireland to the UK

- All drivers must have a high vis, and passport details before arriving to the port



- Do not enter to the port without a booking reference number.
- Do not enter the port without a valid PBN number if sailing to the UK.
- Do not leave any unaccompanied freight in Rosslare Europort after 24 hours of its arrival into the port.
- Drivers of vehicles containing goods should not exit from the Port without clearance from Customs.
- If you do not have the trailer collection documentation at the port, you will be instructed to leave the port.
- Drivers must have a high vis, and passport details before arriving to the port
